# MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is dated this 12<sup>th</sup> Oct 2020, by and between

#### AND

**FLORANIX** a company incorporated under the laws of India and having its office at Block NO.9, 9<sup>th</sup> Lane, Shastri Nagar, Adyar, Chennai-600020 and represented herein by its Founder - President **Dr. G. KUMAR SATHIAN** (hereinafter referred to as "**Second Party**")

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

#### **WHEREAS:**

#### First Party:-

- a) Marudhar Kesari Jain College for Women established in the year 1994, Institution of fine learning where thousands of rural women students have been able to explore better career options & achieve high degrees of success.
- b) Marudhar Kesari Jain College for Women is located on a sprawling campus of 25 acres that provides a congenial atmosphere for teaching and learning. It is Recognised under Sec. 2(f) & 12(B) of the UGC act 1956, approved by Govt. of Tamilnadu, and is permanently affiliated to Thiruvalluvar University. It has been re-accredited with "A" grade by NAAC, Bangalore (UGC recommended) in the year 2019 and certified by BSI as an ISO 9001:2015 certified institution in the year 2018.
- c) Marudhar Kesari Jain College for Women is a self-financing Women Institution. The college is offering **16 U.G. courses**, **11 P.G. courses**, **7 M.Phil. courses and <b>2 Ph.D courses** with 2700 students.

- The Institute of company Secretaries of India in PURSUIT of Professional Excellence statutory body under the act of parliament.
- e) A proactive management & a team of highly dedicated faculty members ensure that learning at Marudhar Kesari Jain College for Women is unique with multi skills development opportunities. For over 25 years MKJC have achieved a long list of accolades with stories of success within the region.

## Second Party:-

- A) FLORANIX is engaged in
  - Conducting Micro Processor, Micro Controller Awareness Programmes
  - Guiding and Supervising MSc Projects based on 8085 Microprocessors, 8051 Microcontroller and ATmega328 based Embedded Microcontroller to PG Students
  - Conducting Workshops on Electronics through mini Projects for UG students
  - Organizing Workshops on Handling Digital Op-amp & Processor based experiments for Staff members
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) FLORANIX has accepted to permit the students to impart training invites premises for the Training program conducted by the First Party. The duration of the implant training in the Second Party's centre will be for a period of one month for a student.

- D) FLORANIX have rights to reject candidate who have failed to fulfill the Second Party Service based quality needs.
- E) FLORANIX is not responsible (or) liable for any fees or incentives with respect to training/ for sourcing candidates.
- F) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

### **CLAUSE 1**

#### **CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will relate effective utilization of the intellectual capabilities of the faculty of Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry.
- 1.3 The general terms for co-operation shall be represented by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

#### **CLAUSE 2**

#### **SCOPE OF THE MOU**

- 2.1 The budding Physics students of B.Sc., M.Sc., and M.Phil., Physics Scholars from the Institutions could play a key role in technological up gradation, innovation and competitiveness of an Electronics and Microprocessor Sector.
- 2.2 Curriculum Design: Second Party can give valuable inputs to the first Party; suitably customize the curriculum and assessment.

During the training each student will be provided with:

- Hands on experience in assembling & soldering circuits on PCB.
- An exposure to testing of various Electronic Trainer kits manufactured by the company.
- Training in assembly level programming / testing with Microprocessors & Microcontroller
- Guidance & supervision to assemble & construct a mini project and to prepare a Project Report.
- 2.3 Industrial Training & Visits: Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; Second Party to permit the Faculty and Students of First Party to visit the company and also involve in In-plant Training at Chennai and Other Outlets. The In-plant training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career.
- 2.4 Research and Development: Both Parties have agreed to carry out the joint research activities in the field of Electronic and Microprocessor sectors.
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party to construct a mini project, prepare a Project Report, soldering circuits, and Techniques for kit assembling, PG Projects, Testing of Trainer Kit and this partnership will also cater to the needs of educational, Training and consultancy programs in the area of 'Sensor Based Electronic Automation and Technology'

- Quest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends in Electronics through mini Projects.
- 2.7 **Faculty Development Programs:** Second Party to train the Faculty members of First Party.
- 2.8 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.
- 2.9 Students selected for instant training shall also execute the documents as required by the Second Party.
- 2.10 No claim against the Second Party shall be valid, either the students or the First Party.

#### **CLAUSE 3**

#### VALIDITY

- 3.1 This Agreement will be valid until it is expressly terminated by either Party during which period first party or second party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of First Party or Second Party, after termination of this agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing.
  In the event of Termination both parties have to discharge their obligations.

## **CLAUSE 4**

# RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent entities, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create

any obligation or liability, express or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to or to extend any liability on behalf of the other Party.

This MOU is executed in two sets and the First Party shall hold first and Second Party shall hold the other.
