GUIDELINES

- 1. The University is responsible for conducting Personal Contact Programme (PCP) classes.
- 2. There shall be a minimum of 30 students enrolled in a particular course if the centre desires to conduct classes at their own place.
- 3. A centre offering DDE courses shall pay a deposit amount of Rs. 50,000/-at the time of affiliation which includes non-refundable fee of Rs.25,000/- Rs. 5000/- as a processing fee and refundable deposit of Rs.20,000/- The DD shall be drawn in favour of "The Registrar, Tamil Nadu Physical Education and Sports University",payable at" Chennai"
- 4. 100% of the course fee shall collected from the students and the same to be paid to the University. The University will send the study centre share 30% after completing the admission process. (30% for using the space for conducting the course (Practical & Theory)
- 5. Competent Faculty approved by the Tamil Nadu Physical Education and Sports University will conduct the conduct classes in 2 spells for whom TA/DA remuneration shall be paid by the University. If any expert available in a particular field in the concerned Institution, they may write to the University for approved for whom the remuneration shall be paid by this University.
- 6. The examination centres shall be announced by the University.
- 7. The Applications and Prospectus shall be obtained by the candidates by paying a Demand Draft of Rs 300/- (Rupees Three Hundred only) drawn in favour of "The Director, School of Distance Education, TNPESU" payable at Chennai.
- 8. 80% of the attendance in PCP classes is mandatory and PCP attendance should reach the School of Distance Education office for all the candidates by the centre's coordinators.
- 9. Filled in applications along with original certificates should reach the the office of the School of Distance Education on Stipulated Date.
- 10. Fee once paid shall neither be refunded nor adjusted towards any other payment.
