#### Summary

The program begun with the prayer song followed by the invocation to Mother Tamil and Ms.Afifa Fathima M of II B.Sc Psychology proposed the welcome address. The Dean, School of Life Sciences, Dr.C.Asokan, and Ms.Sonali Mondal Assistant Professor, Department of Psychology, felicitated the gathering, by explaining the need for taking case histories in clinical settings. Ms. Mehek Anjum C of II B.Sc Psychology introduced the resource person for the day. The session was then handed over to Ms. S.Manjula, Advisor, Knowledge Export – Import Section, All India Psychology Academy, Vellore Sub Office, India.

The resource person clearly explained about what is a case and case history in the field of Psychology. She put forth the following components of a case history like i) Demographic details ii) Presenting Chief complaints iii) History of present illness iv) Family History v) Past Psychiatric and Medical History vi) Childhood history vii) Educational History viii) Occupational history ix) Sexual history x) Marital History xi) Premorbid Personality xii) Alcohol and substance use history xiii) Physical Examination xiv) Suicidal History xv) Mental Status examination.

In the end, she also discussed about the importance of manual like DSM (Diagnostic Statistical Manual of Mental Disorders) and Global Assessment of Functioning (GAF), which provides guidance in diagnosing mental health problems and disorders. She concluded by giving an activity to our students to write at least 10 case summaries by observing 30 case histories.

The students interacted with the resource person effectively, got their queries cleared and registered their valuable feedbacks regarding the session. Vote of thanks was given by Ms. Varshni S of III B.Sc Psychology and the program came to an end by singing the National Anthem.

### Outcome of the Programme

1. The Students gained thorough knowledge on the process of case history taking in clinical settings.
2. The students will be able to implement all the strategies learned through the session during their case history studies.
3. The students understood why case history taking is crucial in diagnosing and managing patient conditions
4. The students would be well equipped to follow a systematic approach to history taking, which often includes structured formats like the SOAP (Subjective, Objective, Assessment, Plan).
5. The students got an idea about proper documentation techniques so as to ensure the accurate and clear recording of patient information.


