MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding is entered into on 31.07.2024 at 9.30 a.m. Chennai between Central Footwear Training Institute (CFTI), MSME- Technology Development Centre (CFTI) 65/1, GST Road, Guindy, Chennai, 600032 and Marudhar Kesari Jain College for Women (Autonomous), Vaniyambadi.

1. Central Footwear Training Institute (CFTI), MSME- Technology Development Centre (TDC), CFTI, Chennai, an institution at 65/1, GST Road, Guindy, Chennai, 600032 represented by K. MURALI, Director, hereinafter referred to as "CFTI, Chennai," which shall mean and include its successors, assigns, and legal representatives.

AND

2. Marudhar Kesari Jain College for Women (Autonomous), Vaniyambadi, Tirupattur District, represented by Dr.M.Inbavalli, Principal, hereinafter referred to as "Marudhar

Kesari Jain College for Women (Autonomous)” Which shall mean include its successors, assigns and legal representatives situated on the above address at which term shall mean and include its successors, assigns, and legal representatives.

WHEREAS:

A. **CFTI, Chennai**, which is a society registered under the aegis of M/o MSME and is a Training Partner (TP) with PMKVY, is keen on identifying unemployed youth and imparting training to them under the PMKVY 4.0 Scheme to create a skilled workforce for the Footwear and allied industries.

B. Both **CFTI, Chennai**, and **Marudhar Kesari Jain College for Women (Autonomous)** wish to work together towards providing training to the candidates to advance their careers and improve their livelihoods.

NOW IT IS HEREBY AGREED THAT:

1. Effective Date and Duration: This MOU comes into effect from **31.07.2024** and shall remain effective until its termination as provided for below.

2. Courses and Duration: The following courses under PMKVY are based on the approved QPs (a set of National Occupational Standards):

- i. Stitching Operator (Footwear) (LSS/Q2501) - 38 Days (8 hrs/Day)
- ii. Stitcher Leather Goods and Garments (LSS/Q5501) - 38 Days (8 hrs/Day)
- iii. Pre-Assembly Operator (LSS/Q2601) (4.0) - 38 Days (8 hrs/Day)

A. CFTI, Chennai Undertakes:

i. To provide training to the enrolled candidates by deputing one Trainer (Subject Matter Expert) at the **Marudhar Kesari Jain College for Women (Autonomous)** premises and ensure that the quality of training meets the standards set by PMKVY.

ii. To assign a Trainer who will monitor:

- a. The SME training & Certification,
- b. The overall training process, including day-to-day evaluation, adherence to schedules,
- c. Internal Assessment of Candidates,
- d. Coordination of the Certification of candidates,
- e. Any other related activities.

iii. To provide all instruction manuals, lessons, and learning tools necessary for the required training with detailed course content to all the candidates.

iv. To facilitate regular assessments of candidates' progress as per PMKVY 4.0 requirements during the course and the final assessment by an Assessment Firm approved by PMKVY.

v. To facilitate the certification at the end of the successful completion of the training and on receipt of the Certificate issued under the PMKVY 4.0 Scheme by the Govt. of India.

vi. To facilitate the receipt of monetary incentives available to the candidates directly to their individual bank accounts by PMKVY at the end of the successful training completion.

vii. To ensure supervision of the entire training activities by appointing a Coordinator who will monitor the quality of training on behalf of CFTI, Chennai.

viii. It is mutually agreed upon that the mobilization charges will be Rs. 250/- per candidate and Rs. 7500 Rental for the Building per Batch.

ix. The mobilization charges will be released by CFTI, Chennai only after completion of the assessment by the assessment agency, and the payment of mobilization charges will be restricted to the candidates who actually appeared for the final assessment.
